#### Chairman's Message

As the Chairman of the Regional Access Project Foundation, I speak on behalf of the board and staff to express how proud we are for the supporting role RAP played in response to the COVID-19 pandemic. RAP exists because of unmet needs and those needs are even greater than ever before.

Our community has emerged from quarantine, thanks to vaccine availability. Businesses are opening up and people are returning to work. These are encouraging signs but there is still a great deal of healing and recovering that needs to take place.

RAP partnered with the County of Riverside throughout 2020 to distribute masks to nonprofits in the Coachella and Palo Verde Valleys. We also were able to assist with the administration of \$7.3 million CARES funds to Skilled Nursing Facilities throughout Riverside County to help them keep their residents and families safe.

We also had a successful partnership with the Desert HealthCare District. This relationship resulted in a joint funding pool, providing financial assistance to nonprofits continuing to serve clients at the beginning of the pandemic and once again in early 2021 to those nonprofits still struggling financially.

RAP recognizes that our world has changed a great deal. Health concerns with COVID-19 and its variants remain. In addition, there are racial, social, and political issues which have emerged. It is through difficult times like these that we are reminded of the great opportunity we have to make a positive difference by being able to support our nonprofit and public agencies as they provide essential services to residents.








#### RAP FOUNDATION FINANCIAL CHART
