 - 1. **MENTAL HEALTH INITIATIVE** (**MHI**) **REQUEST FOR PROPOSALS Grants** RAP released the Request for Proposal (RFP) on January 30, 2023, in partnership with the Desert Healthcare District. Each organization allocated \$500,000 for a total of \$1M. In addition, both entities are investing (a total of \$72,450)n capacity building services to be provided by NPO Centric. The applications which were invited to apply focused on improving the psychological, emotional, physical, and social well-being of residents of the Coachella and Palo Verde Valleys. The RFP includes a Strategy Map which identifies the following specific Strategies:
 - Improve quality of MH services to remote areas through innovative systems that address policy, access, and delivery channels.
 - Improve awareness of mental and emotional health resource services for residents north of Palm Springs to Blythe through systems that address access, policy, and delivery channels.
 - Support cultural competency of service providers and reduction of language/stigma/cultural barriers to service access for clients.
