V. New Business - Action May Be Required

A. The County of Riverside accepted the proposal submitted by Inland So. CA United Way which has partnered with IE Community Foundation and RAP for ARPA funds of \$14.5M. The grant period is April – June 30, 2024. Funds are for programs, services, or capital expenditures, loans or grants to mitigate financial hardship such as declines in revenues or increased costs, or technical assistance.

The Breakdown is as follows:

Financial Support Funds administered by IE So. CA; Programmatic Support funds administered by IECF and Technical Support funds administered by RAP.

Grant applications to be made available April 1, 2023 and funding available in June, with multiple rounds. Technical assistance will be an option on all grant applications and will begin in April

- 1. **Direct Financial Support and Assistance** this category of assistance is specifically designed to address impacted non-profit organizations that experienced public health or negative economic impacts due to the pandemic. Assistance provided under this category will combine financial grants and technical assistance to support the improvements of operational and fiscal capacity. The anticipated grant level is \$50,000-\$150,000 per nonprofit to be awarded to approximately 50-60 grantees total.
- 2. **Programmatic Funding** a second broad category of funding that is recommended to financially support programming and services for disproportionately impacted communities including those communities with low Healthy Places Index (HPI) scores to advance the County's HPI goals and initiatives. The anticipated grant level is \$50,000-\$150,000 per nonprofit to be awarded to approximately 30-40 grantees.

The amount allocated for Technical Assistance is \$649Kplus the RAP admin of \$323,549 (Table
