lyengar Yoga is a system of Hatha yoga developed by B.K.S. lyengar, emphasizing precision, alignment, and mindful sequencing of postures. This method cultivates strength, flexibility, balance, and mental focus through sustained holds and the use of props such as blocks, straps, chairs, and blankets to make yoga accessible to practitioners of all ages and abilities. Iyengar yoga is especially beneficial for older adults and individuals with physical limitations, offering a therapeutic approach that supports holistic well-being. IYCCV prioritizes serving marginalized and underserved communities, offering general classes for all levels of practice; adaptive classes for older adults and youth; and medical classes designed for residents recovering from cancer treatment, open-heart surgery, hip, and knee replacement, or an illness. Classes are offered year-round in both English and Spanish. The introduction of an online streaming component for the general classes has further expanded accessibility, enabling students to join classes from the comfort and safety of their homes. The Yoga Center is located in Palm Desert at 73875 CA-111.
