C. Request from Cathedral City Mayor Nancy Ross for RAP to serve as a Fiscal Sponsor for an Employee Appreciation event for Riverside County Animal Campus employees, approximately 70-80 people. The event date is to be determined but possibly in November at the Old Spaghetti Factory in Rancho Mirage. There are verbal commitments from 4 elected officials for a total of \$8,000 and there would be only one vendor to pay. Therefore Administrative functions be limited.
