B. LOI - OneFuture Coachella Valley

The Administrative Director conducted research to identify a new HVAC company for quarterly maintenance and as-needed repairs. A recommendation for a new HVAC provider will be presented.

Staff Recommendation: Staff recommends assigning the contract to **Titans** based on their competitive pricing, comprehensive quarterly service plan, and strong customer service. Titans offers the most cost-effective option at \$7,552 annually, includes full maintenance for all 32 units, and provides a 20% discount on repair services. Additionally, they waive diagnostic fees when repairs are approved, further reducing potential costs.
