RCLC has identified a significant gap in mental health services within the Blythe community. Two years ago, RCLC began providing mental health support in Blythe and quickly recognized the critical need for expanded services. The funding request is to address the gap and extend services to this underserved population. In partnership with the PV Unified School District (PVUSD), this program will enhance accessibility to mental health services in the region. PVUSD has proven to be a valuable partner and trusted link to the community and leverages their expertise in understanding local needs. Both will engage the community through targeted outreach efforts, educate residents about available mental health resources, and facilitate access to care. RCLC clinician, specifically designated for this program together with the PVUSD will work on identifying individuals and families in need of services.

Summer Brain Gain is a summer learning loss prevention program developed for Boys & Girls Clubs to integrate into their traditional summer schedule. It comprises one-week modules with fun, themed activities for elementary, middle, and high school students aligned with common core anchor standards. Integrated with the Boys & Girls Club of Palm Springs summer schedule, the WAVE Program focuses on four key areas: Water Safety, Aquatic Skills, Vitality, and Enjoyment. WAVE provides a safe and enjoyable environment for children (Grades 1 to middle school) during the desert's hottest season. Children learn water safety, develop swimming techniques, engage in physical fitness, and enjoy pool activities. Sessions include 5 minutes of changing time, 5 minutes of warm-up, 40 minutes of water time, and 10 minutes of changing time, followed by a healthy snack. The program is held in the indoor Pathfinder Pool Pavilion on the Boys & Girls Club campus.

Each rider is eased into a program of physical exercise geared to their needs. Immobility causes good muscles to atrophy which can lead to further problems. At Pegasus, we try to strengthen the muscles and joints with these exercises along with the effort required in mounting, dismounting and riding a horse.

These programs address the urgent needs of vulnerable populations within these communities. In addition to linking clients with permanent supportive housing and rapid re-housing services, Step Up offers a comprehensive array of services designed to help members heal, become self-sufficient, foster belonging, and maintain stable housing. Services include psychiatric and physical healthcare, case management, life skills education, crisis intervention, and connections to community resources like medical and dental care, mental health and substance use counseling, childcare, and workforce development services. As the only local service provider in the Coachella Valley contracted for both ECM and CS programs, Step Up has become the agency of choice for local health plans making referrals.

RISE Coachella: Resilience, Inclusion, Strength & Empowerment Collective is an inclusive, trauma-informed wellness program for youth ages 8–17 in eastern Riverside County who are neurodivergent, have intellectual or developmental disabilities (IDD), experience emotional or behavioral challenges, or have been impacted by adversity such as poverty or trauma. Each 8-week cohort meets weekly and includes structured, engaging activities such as adaptive fitness, guided group interaction, creative expression, mindfulness, and life skills development. Sessions are led by trained mentors and educators, many of whom bring lived experience in special education, trauma recovery, and youth empowerment. Youth participate in emotional check-ins, sensory-integrated play, collaborative challenges, and personalized goal-setting. The program fosters a nurturing space where participants build trust, strengthen social bonds, and develop tools for resilience and self-regulation.
